

The help is there because workers from all over Decatur and Macon County have reached into their pockets and given generously to the yearly campaign for funds and support these needed agencies.

Even though the economy is improving there are still people who need help. Let's keep the help and the hope coming, by giving again this year generously from the heart.



In hard times people depend upon hope. Everyone of us knows someone who can use the services provided by the United Way. And some people really need these services, and depend on them.

Here are a few services that may help a needy neighbor: rehabilitation by the Visiting Nurses; day care and instruction for pre-schoolers by the Self-Start Program; and guidance and food from the Salvation Army. The Community Health Improvement Center provides non-emergency health care and education for those who do not have a physician. The Council of Community Services plans development of health and welfare needs.

The YMCA with its recreational activities also has Big Brother/Big Sister Programs. Casework and couseling services by Family Service help with problems such as marital, parent-child relationships, and aging.
